- Port Workshop. Master Plan Update. Thursday, April 27, 9:30AM
 Wyndham San Diego Bayside, 1355 Harbor Drive.
- **Port Workshop.** North Embarcadero. Staff proposed two alternatives for Harbor Drive from B St Pier to Grape. First narrows Harbor Drive and moves to east, very similar to NEVP. Second closes Harbor Drive from Ash to Grape to thru traffic. Most participants seemed to prefer first alternative.
- **DCPC Elections**. Congrats to new members and thanks to members not returning. See <u>DCPCSD.com</u> for results.
- **Navy Broadway Complex** (NBC). Demolition has started on the project now known as Manchester Pacific Gateway. The Navy Building NW corner of Pacific Highway and G St will be built first, Navy move in, remainder of site demoed. Expect construction on the site to continue through 2020.
- **Homeless.** Downtown has at least 859 Supportive Housing units and over 1400 shelter beds. The majority of all those in the City. Your Board believes that the areas outside of Downtown should share in the solutions to homeless issues by accepting additional housing.
