- **Horton Plaza Park.** Grand opening **May 4**. https://www.westfield.com/ hortonplaza/park and click "calendar" in Events section to see the schedule.
- R'R Marathon. Sun. June 5. New route will use B St from 17th to 5th, 5th from B St to Ash, Ash from 5th to the finish line at Waterfront Park. Band locations later. Expect Harbor and Pacific Highway around Waterfront Park to be heavily impacted.
- Mobility Plan. To Planning Commission then City Council. Community disagreements mainly focused on perceived loss of parking spaces. To put in a cycle track you either change diagonal parking to parallel or eliminate a traffic lane. Roadway becomes: sidewalk, cycle track, parking, traffic, parking sidewalk. There is no "barrier" between traffic and cycle track except the parking lane and markings. Most of the "lost" parking will be replaced by narrowing other streets and changing parallel to diagonal parking. Most discussion focused on whether State St or Kettner Blvd should have cycle track north of Beech St and whether any street other than Beech would serve for East/West crosstown cycle track route.

Possible Whole Foods, Possible Ritz Carlton Hotel, plus condos, plus apts, plus office, plus 34 affordable units, plus restore historic Cleremont Hotel (and Black History Museum), plus public parking. Consent: CUP for Entertaiment, Blue Moon Hookah Lounge 818 6th Ave, CUP for Educational Facility in Residential Zone. CA Int Bus Univ 1660 Union, Map Waiver Ball Park Village to allow conversion to Condos.

Action:

Entrada. Little Italy, 1953 India St. Revocation of CUP due to numerous violations of noise levels and hours of operation. Recommend to hearing officer to revoke CUP for entertainment.

Downtown Mobility Plan.

Plan modifies the Community plan to reflect a bicycle network, pedestrian oriented green streets, defines main auto and transit corridors within Downtown. Many neighborhoods object to the projected loss in parking spaces when either a green street or bicycle cycleway is installed. Green streets remove one lane of parking and extend the sidewalk by that amount. Cycleways move the parking lane away from the curb and eliminate one travel lane or change diagonal parking to parallel parking. The plan calls for replacing parking by converting other streets from parallel to diagonal and adding parking under future parks. Two separate motions were approved. First would require replacement parking to be

place before any was eliminated. The second, passing by one vote, recommended that the whole plan be revised.
